UPDATE ON "IMPORTANT MESSAGE FROM MEDICARE"

Beginning on July 1, 2007, hospitals must deliver a revised version of the "Important Message from Medicare" to inform Medicare beneficiaries who are hospital inpatients about their hospital discharge appeal rights. Notice is required both for original Medicare beneficiaries and for beneficiaries enrolled in Medicare health plans.

Summary of Final Rule:

Hospitals will be required to issue a revised version of the *Important Message from Medicare* that fully explains patients' discharge rights. Rather than issuing a second and different notice twenty four hours before discharge as was proposed, the hospital must deliver the revised *Important Message from Medicare* at or near admission, but no later than (two) calendar days after the beneficiary's admission to the hospital. This applies to Medicare fee-for-service and Medicare Advantage patients. The Hospital must have the patient or his/her rep-

resentative sign the notice and answer any questions that the patient or his/her representative might have concerning the content of the notice. The hospital must provide the original, signed notice to the beneficiary and retain a copy of the signed notice.

The hospital must also deliver a copy of the signed *Important Message from Medicare* to Medicare fee-for-service and Medicare Advantage patients before discharge.

The Notice should be given not more than two (2) calendar days before the day of discharge. CMS believes that this follow-up notice will serve as a reminder of the earlier notification about the beneficiary's discharge rights. This step would not be required if the initial delivery and signing of the *Important Message from Medicare* took place within two (2) days of discharge.

Joint Effort in Documentation

The Medicare prospective payment system has placed greater importance on complete and accurate documentation in the medical record. In order to achieve such documentation, open communication must take place between Physicians and the medical records staff. The importance of consistent, complete documentation in the medical record cannot be overemphasized. Without such documentation the application of all coding guidelines is a difficult, if not impossible, task.

The importance of ensuring that diagnoses are substantiated by the diagnostic findings documented in the medical record is imperative. The Uniform Hospital Discharge Data Set (UHDDS), whose standards are the common core of data on individual hospital discharges, definition of principle diagnosis (the condition established after study to be chiefly responsible for occasioning admission to the hospital) needs to be reinforced on an ongoing basis.

Although you do not need to know how to assign ICD-9-CM codes, you must have some understanding of the classification scheme to guarantee that diagnoses are documented at the appropriate level of specificity. Documentation of additional diagnoses associated with the current hospital stay is equally important to ensure correct DRG assignment. The medical staff must be informed that diagnoses related to an earlier episode that have no bearing on the current hospital stay are to be excluded.

Coders may approach you with documentation questions, but please be assured that the clinical management of the case is not being challenged, but the documentation appears to be incomplete or unclear.
